
At the outset the Managing Director, welcomed the members of the Tender Committee.


2. The Committee noted that altogether 5 no. of bids were uploaded on e-procurement website till the last day and time of submission of Bid that is 08.09.2020, up to 15:00 hrs. The bidders are as follow:
  - i. M/s Technify Solutions Pvt. Ltd.
  - ii. M/s Rollz India Waste Management Pvt. Ltd.
  - iii. M/s Singhal Enterprises
  - iv. M/s Madras Security Printers Private Limited
  - v. M/s Philogy Consulting Services P Ltd.
3. The Technical bids uploaded by the bidders were downloaded from e-procurement website after the date of bid opening that is on 09.09.2020, 11.00 hrs. Thereafter, before evaluation of technical bids, the Tender fee and Bid Security were verified, which were found to be in order.
4. The Committee noted the marks provided during Technical Evaluation to the bidder, as per Technical Marking Matrix mentioned in **Clause 27.2 of Section-1: Instruction to Bidders** and agreed with the same. The mark so obtained by these 5 bidders are tabulated overleaf.



Ltd. could obtain the required qualifying marks of 70 or above (out of 100), only the aforementioned two bidders are declared **technically responsive** and financial bids of these bidders are recommended for further evaluation.
