2. The Tender Committee recalled that in its meeting held earlier on 09.09.2020 they had recommended opening of the financial bids of two responsive bidders, after mandatory time of uploading of technical proceeding on the e-proc site, provided no claim or objection are received.
3. The Committee was informed that an objection has been received from M/s Rollz India Waste Management Pvt. Ltd. vide letter No Rollz/PSCL/Gen/IT/20-21/079 dated 11.09.2020, requesting to consider their claim/point of view on allotment of marks to them based upon different attributes/criteria, during technical evaluation of their bids.
4. Considering this request of M/s Rollz India Waste Management Pvt. Ltd. the Tender Committee re-evaluated their technical bids along with other four bids.
