

- 1. The Tender Committee which held its meeting on 09.09,2020 had declared the following two bidders technically responsive:
 - M/s Techinfy Solutions Pvt. Ltd.
 - ii. M/s Madras Security Printers Private Limited

The proceeding of the technical evaluation was uploaded on the e-procurement site and kept open for receipt of claims/objection, if any. The proceedings were also uploaded on the website of Patna Smart City Ltd.

- 2. Only one representation was received from M/s Rollz India Waste Management Pvt. Ltd. requesting for review the evaluation. The Tender Committee considered this request and accordingly held its meeting on 16.00 hrs. on 16.09.2020 to review the evaluation of technical bids. The committee on review could not find any discrepancy in the technical evaluation of bids carried out earlier. The proceeding of this review meeting was uploaded on the website of Patna Smart City Ltd on 16.09.2020.
- 3. Thereafter, the financial bids of two responsive bidders were opened at 18.00 hrs. on 16.09, 2020. The abstract of the financial bids are tabulated below:

- 4. The year to year variation between OPEX of any two consecutive years is not more than 15% as quoted by the lowest bidder M/s Techinfy Solutions Pvt. Ltd. The percentage variation between the highest annual OPEX of Rs. 1,14,13,898.16 and lowest OPEX of Rs. 1,06,59,338.36 is only 5.3% and hence below 15% which is in accordance to Clause no. 22 (iv) of RFP.
- 5. The OPEX quoted by the lowest bidder M/s Techinfy Solutions Pvt. Ltd is not less than 40% which is in accordance to Clause no. 22(iv) of RFP.
- 6. Since M/s Techinfy Solutions Pvt. Ltd has adhered to all the financial criteria/limits mentioned in the RFP and is the L1 bidder, who has quoted 6.93% higher than the estimated cost of Rs. 12,61,61,154/-; the Tender Committee recommends calling M/s Techinfy Solutions Pvt. Ltd for negotiation.
