1. At the outset the Managing Director welcomed all the members of the Tender Committee.
2. The Tender Committee noted that till the stipulated date and time of submission of bids i.e., 16.00 hours on 23.02.2023, as indicated in NIT dated 02.02.2023; only one bid from M/s M P BABARIYA was uploaded on the e-procurement website.
3. Further, the Committee noted that after successful verification of the EMD through the respective banks, the single uploaded bid was downloaded from the e-procurement website after 14:00 hours on 24.02.2023, the due date and time of opening of technical bids.
4. Thereafter, the Technical Evaluation Sheet on the basis of the information submitted online in respect of the bid received in response to the NIT No. 20/MD/PSCL/2022-23 dated 02.02.2023, floated by PSCL, was prepared by the Evaluation Committee.
5. The Tender Committee went through the technical evaluation made by the aforementioned Committee and agreed with the same. Accordingly, based upon the qualification criteria mentioned in the RFP, the Tender Committee declares the **following bidder as technically responsive**, reason as mentioned below: -
