- 1. At the outset the Managing Director welcomed all the members of the Tender Committee.
- 2. The Tender Committee noted that till the stipulated date and time of submission of online bids i.e., 15:00 hours on 20.02.2023, as indicated in NIT dated 18.01.2023; (two) bids from following 2 (two) bidders were uploaded on the e-procurement website:
  - i. M/s Vijendra Kumar
  - ii. M/s Aaliyas Home Pvt. Ltd.
- 3. Further, the Committee noted that only after successful verification of the EMD through the respective banks, these two uploaded bids were downloaded from the e-procurement website; that too after 14:00 hours on 21.02.2023, the due date and time of opening of technical bids.
- 4. Thereafter, the Technical Evaluation Sheet containing information online in respect of all the two bids received in response to the NIT No 18/MD/PSCL/2022-23 dated 18.01.2023, floated by PSCL, was prepared by the specially constituted Evaluation Committee.
- 5. The Tender Committee went through the technical evaluation made by the aforementioned Committee and agreed with the same.
