- ii. M/s Amazing India Contractors Pvt. Ltd.



The Tender Committee also recommended for opening of Financial Bids; after obtaining approval of the Competent Authority.


3. On due date i.e 28.03.2023 upto 15:0 hours no objection and claim has been received as mentioned in above para-2. Both technically responsive bidders were informed through email on 04.04.2023 to attend the opening of financial bid on 05.04.2023.

4. On scheduled date of opening i.e., 05.04.2023, both the bidder's representatives have attended the opening of financial bids where tender committee opened the sealed envelope in front of bidders representative. The detail of financial proposals are as follows:


