INTRODUCTION

Patna Smart City Limited (PSCL) is a Special Purpose Vehicle created under the Patna Municipal Corporation to deliver several Pan City and Area Based Development initiatives with a focus on infrastructure and ICT advancements at strategic locations in the city.

The Ministry of Housing and Urban Development (MoHUA), Government of India (GoI) has initiated Smart Cities Mission (SCM), under which selected cities are being developed as smart cities with a focus on improving citizen services with ICT intervention. Smart Cities Mission (SCM) is an urban renewal and retrofitting program by the Government of India with a mission to develop 100 cities all over the country making them citizen-friendly, sustainable and investment destinations. Under the smart city scheme, the Government has emphasized to improve the basic civic amenities of the cities on one hand and the provision of modern technological advances for ease of living on the other hand. The Smart City Proposal for Patna envisions to implementing a number of projects categorized into Area Based Development (ABD) projects and Pan City components. The ABD projects focuses on physical infrastructure components, whereas the Pan City components focus on the ICT interventions in the city. To achieve Patna's vision for a smart city, large numbers of measures are required to be implemented.

Considering the priorities echoed by stakeholders during the consultative process and practical feasibility, one of the initiatives shortlisted is "RIVERFRONT DEVELOPMENT NEAR GANGA PATH UNDER PATNA SMART CITY, PATNA (BIHAR)" 500 Prefabricated shops are proposed to be installed in the vending zone of this project.

Scope of Work


Prefabricated shops will have following specification-

1. Prefab light gauge profiled frame work construction.
2. In built plumbing with internal drain provisions
3. Mild steel (cold rolled) structure specially corrugated exterior cladding (lipped type)
4. Lipped profile internal frame work for interior panelling
5. Mineral wool insulation jacketed type upto 50 mm with 36 kg/m³ density.
6. Aluminium composite panel interior cladding with min^m 4mm thick panels where aluminium metal thickness is 0.6 mm or above
7. All weather enclosed design to with stand intense heat rain and cold
8. Automotive grade exterior painting using 7 stage painting process for strong adhesion
9. Provision for LED Branding display with high lumin display provisions
10. Pre built towing arrangement with jack locking provision for theft protection
11. Cross flow ventilation with motorised exhaust min^m sweep 450 mm.
12. Concealed electrical wiring with suitable electrical protection through MCCB and ELCB
13. Provision for solar power with battery bank upto 2 kw
14. Tentative sizes for the Prefabricated shops (1) 8x6 ft, (2) 6x4 ft, (3) 12x8 ft, (4) 10x6 ft, and cart- (1) 7x3 ft, (2) 6x3 ft, (3) 5x3 ft
15. The quotation is required to visit the site and prepare the proposal accordingly.
16. The quotation is required to give presentation before the committee of PSCL. Quotation of only those quotationers will be considered for financial evaluation who will qualify in the presentation.

Note: - Rate quoted should be inclusive of all types of taxes etc.
