



**PROCEEDINGS OF THE TENDER COMMITTEE MEETING HELD ON DATE-30/05/2025**

1. At the outset the Managing Director welcomed all the members in the Tender committee.
  2. The Tender Committee noted that till the stipulated date & time of submission of Bids at 13.05.2025, 17:00 hrs. as indicated in NIT NO. 01/MD/PSCL/2025-26, dated- 19.04.2025 on due date & time total five agencies have uploaded their documents on the e-procurement2.0 website, details are as below.
    - i. M/S SUNIL INDUSTRIES
    - ii. M/S H.P RAJYAGURU
    - iii. M/S SARK INFRA
    - iv. M/S REENA ENGINEERING
    - v. M/S PARK LAYER
  3. Further, the Tender Committee noted that all the five agencies have submitted the EMD further uploaded Bids were downloaded from the e-procurement2.0 website on 14.05.2025 after the due date & time of opening of Technical Bids.
  4. Thereafter the Technical Evaluation sheet on the basis of the information submitted online in respect of the bids received in response to the NIT NO. 01/MD/PSCL/2025-26, dated- 19.04.2025 floated by PSCL was prepared by the evaluation committee.
  5. As per the evaluation of the documents by the technical evaluation committee, M/s HP Rajyaguru was found non-responsive, because vide email letter dated- 22.05.2025 sent by BUIDCo it has been reported that FIR against M/s HP Rajyaguru has been lodged by CBI on 15.09.2023. As per sub clause (J), clause- 4.3 of para 4 of General section I of SBD, M/s Rajyaguru is being disqualified for concealing the information regarding any litigation, current or during the last five years, in


which the bidder is involved, the parties concerned and dispute amount. Show cause may be issued to M/s HP Rajyaguru for concealing the facts in regard to the case lodged by CBI. The tender committee recommended the successful bidders based upon the qualification criteria mentioned in the RFP. The tender committee declared four (04) bidders technically responsive. The details are given in the below table:



7. The Tender committee reviewed the claims received through mail on dated 29 May 2025 and claims submitted by M/s H.P Rajyaguru & M/s Sark Infra mentioned in below table:
